Harbury e-Wheels Fund Raising Campaign

Harbury e-Wheels is a volunteer driver transport scheme using the village's E-Car Club cars to provide safe reliable transport for those in the immediate local communities who, for physical, mental or financial reasons have few or no transport options and therefore no means of getting to hospital, the dentist, essential appointments, or the shops for critical items.

e-Wheels works with local agencies such as Food Banks, Children's Centres, Surgeries and Citizens Advice Bureau Services on a referral basis. It is a community led initiative, not a commercial franchise.

To provide and maintain this low carbon clean transport service to those needing it at absolutely NO COST, e-Wheels needs to raise an estimated £5,000.00 annually.

e-Wheels has been granted permission by HM Revenue and Customs to operate a Gift Aid scheme. This means that on any donations we receive from tax paying individuals we are able to claim an additional 25% from the Inland Revenue at no extra cost to the donor.

e-Wheels is inviting all residents in the local community to support this initiative through an annual standing order.

For instance, if:
